Recitals

a. This agreement confirms the offer of the above Sponsorship Fee by the Sponsor to the WBA towards the holding of the above listed event.

b. The WBA accepts your offer on the terms set out in this agreement.

1. Scope of Agreement

Business Award Category sponsorship by Sponsor as outlined in Clause 2 of this Agreement. The WBA acknowledgement of sponsorship and provision of sponsorship rights as outlined in Clause 3 of this Agreement.

2. Sponsorship Fees

In consideration of the grant of Business Award Category sponsorship rights, the Sponsor agrees to contribute the above Sponsorship Fee to the WBA towards the cost of holding the event. The WBA agrees to use the sponsorship contribution for the sole purpose of the awards program. The WBA will accept the Sponsor's evaluation of goods and services for the purposes of the contract.

3. Sponsorship Rights

The sponsor shall be entitled to the benefits outlined above and as specified within the current sponsorship package, in accordance with the selected sponsorship type.

4. Cooperation

a. Both WBA and the Sponsor will use all reasonable endeavors to conduct themselves in a manner to present a professional and high-quality promotion and image of business.

b. If in the case that staff changes occur at the Sponsor, it is the responsibility of the Sponsor to provide WBA with written details of an alternative main point of contact for the sponsorship agreement within 2 weeks of the changes.

c. WBA must not bring into disrepute or otherwise damage the name or goodwill of the Sponsor.

d. The Sponsor must not bring into disrepute or otherwise damage the name or image of the WBA.

e. WBA will use its best endeavors to ensure that all third parties act consistently with the Sponsorship Rights and Sponsorship Benefits set out in this agreement and do everything necessary for the Sponsor to perform its obligations under this agreement.

f. The parties will use their respective best endeavors to prevent any third party from infringing the rights of either party and if necessary, take reasonable action to stop any actions and protect those rights.

5. Consent Required

The Sponsor agrees and acknowledges that all speeches and communications, and promotional items:

a. must be provided to WBA prior to their delivery and/or circulation by the time stated in this

agreement or, where no time is specified, within a reasonable time; and

b. are subject to prior written approval from WBA which it may withhold in its absolute discretion.

6. Banners and Equipment

• The Sponsor must ensure that all banners and signage are provided to the WBA in a timely manner and not less than 48 hours prior to the event.

 The WBA will be responsible for the security of all banners and equipment after it has been delivered by the Sponsor to the WBA, venue, or event.

• The WBA will be responsible for the proper and effective installation, dismantling and packaging of all signage and equipment, unless otherwise provided in this agreement.

The WBA will endeavor to ensure that the Sponsor's banner is best positioned in prime locations for maximum exposure at events and for any media coverage.

Subject to wear and tear, the WBA will ensure that all banners and equipment remains in a

presentable condition.

• The Sponsor must collect all banners and equipment when requested.



7. Termination

7.1 Mutual Termination Events for Default

Either the Sponsor or WBA may immediately terminate this agreement by written notice if:

- a. One party breaches a material term of this agreement; and
 - i. (i) It cannot be remedied; or
 - ii. (ii)If capable of being remedied, such breach is not remedied within 14 business days of a written request by the other party to remedy that failure;
- b. It becomes illegal for one party to perform any of its material obligations under this agreement; or c. An insolvency event occurs in relation to either party.

7.2 Sponsor Grounds for Termination for Default

- a. The Sponsor may immediately terminate this agreement by written notice to WBA if the Sponsor's name is, in the reasonable opinion of the Sponsor brought into disrepute by WBA or by being associated with WBA.
- b. Upon termination of this agreement by the Sponsor, WBA will refund to the Sponsor any Sponsorship Monies paid by the Sponsor in advance and which relates to the Sponsor Benefits it has paid for but not yet received and which WBA has not paid or committed to pay to a third party.

7.3 WBA Grounds for Termination for Default

- a. WBA may immediately terminate this agreement by written notice to the Sponsor if WBA's name is, in the reasonable opinion of WBA brought into disrepute by the Sponsor or by being associated with the Sponsor.
- b. Upon termination of this agreement by WBA, the Sponsor will forfeit any monies already paid in Sponsorship Monies and all rights referred to in this agreement or otherwise.

8. Dispute Resolution

If a dispute arises between the parties, the complainant must not commence any court or arbitration proceedings, except where that party seeks urgent interlocutory relief, unless it has first complied with this clause:

- a. Notification The complainant must inform the respondent in writing of the following:
 - i. The nature of the dispute;
 - ii. The outcome the complainant desires, and
 - iii. The action the complainant believes will settle the dispute.
- b. Endeavour to resolve dispute On receipt of the complaint by the respondent, both parties will make every effort to resolve the dispute by mutual negotiation within 14 business days.

c. Mediation

- i. If the dispute is not resolved within 21 business days of the respondent receiving notice, either party may refer the dispute to mediation administered by the Australian Commercial Disputes Centre (ACDC).
- ii. The mediation must be conducted in accordance with the ACDC guidelines for commercial mediation operating at the time the dispute is referred to ACDC.
- iii. The guidelines set out the procedures to be adopted, the process of selection of the mediator and the costs involved.
- iv. The terms of the guidelines are deemed incorporated into this agreement.
- v. Each party must attend the mediation.
- vi. The parties are equally liable for the cost of mediation unless otherwise agreed upon in writing.
- vii. Each party will pay their own cost of attending the mediation.
- viii. This clause does not affect the rights of a party to the agreement to take legal proceedings under the agreement.
- d. Right to terminate If the dispute has not been resolved after 30 days from commencement of mediation, either party may request the mediator to terminate the mediation.
- e. Survival of clause This clause survives termination of this agreement.





9. Amendments

No amendment or variation of this agreement is valid or binding on a party unless in writing and executed by all parties.

10. Entire Agreement

This agreement is the entire agreement and understanding between the parties on everything connected with the subject matter of this agreement, and supersedes any prior understanding, arrangement, representation or agreements between the parties as to the subject matter contained in this agreement.

11. Events Beyond Control

Neither party shall be liable to the other party for any loss caused by any failure to observe the terms and conditions of this agreement, where such failure is occasioned by causes beyond its reasonable control including but not limited to by pandemic, fire, flood, riot, strike, war, restrictions and prohibitions or any other actions by any government or semi government authorities.

12. Severance

If anything in this agreement is unenforceable, illegal or void, it is severed and the rest of the agreement remains in force.

13. Notices

A communication required by this agreement, by a party to another, must be in writing and may be given to them by being:

- a. Delivered personally; or
- b. Posted to their address specified in this agreement, or as later notified by them, in which case it will be treated as having been received on the second business day after posting; or
- c. Faxed to the facsimile number of the party with acknowledgment of receipt received electronically by the sender, when it will be treated as received on the day of sending; or
- d. Sent by email to their email address, when it will be treated as received when it enters the recipient's information system.

14. Counterparts

This agreement may be executed in any number of counterparts each of which will be an original, but such counterparts together will constitute one and the same instrument and the date of the agreement will be the date on which it is executed by the last party.
